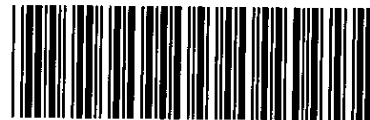

Statement of Reasons connected with ceasing to hold office as Auditors

In accordance with Section 519 of the Companies Act 2006 (the "Act"), we set out below the reasons connected with PricewaterhouseCoopers LLP, registered auditor number COO1004062, ceasing to hold office as auditors of Eagle Star Holdings Limited, registered no: 01416463 (the "Company") effective from 07 July 2021.

The reason we are ceasing to hold office is that the parent company undertook a competitive tender process for the position of statutory auditor and we mutually agreed with the Audit Committee not to participate due to the time of our tenure. The directors have indicated to us that they wish to appoint the group auditors as auditors of all the subsidiaries in the group.
