Statement of directors' responsibilities

We have audited the financial statements of Warner/Chappell UK Limited for the year ended 30 September 2014 which comprise the Balance Sheet and the related notes 1 to 9. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

In our opinion the information given in the Strategic Report and Directors' Report for the financial year for which the financial statements are prepared is consistent with the financial statements.

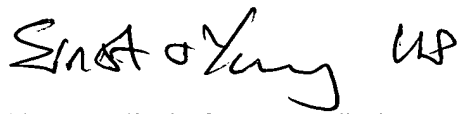

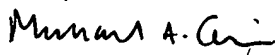

Notes to the financial statements

at 30 September 2014

1. Accounting policies

Basis of Preparation

The financial statements are prepared under the historical cost convention in accordance with applicable accounting standards.

Accounting convention

Under an Exploitation Agreement dated 1 July 1997 Warner/Chappell Music Limited, a fellow subsidiary undertaking, accepted the benefit and burden of the company's rights and obligations under its current and future contracts with third parties. Under the Exploitation Agreement the company's directors have the right to set an annual fee chargeable to Warner/Chappell Music Limited. In the current year this fee was set at £nil (2013 £nil).

Cash flow statement

The company has taken advantage of the exemption in the Financial Reporting Standard No.1 Revised (FRS1). A cash flow statement has not been prepared because as at the year end, the company was a wholly owned subsidiary undertaking of Warner Music Group Corp., a company incorporated in the United States of America, which prepares a group cash flow statement.

Going concern

Given the fact that the company does not trade and has positive net assets the directors believe that the company has adequate financial resources to continue in operation for the foreseeable future. The accounts have therefore been prepared on the going concern basis.

Audit Fees

Audit Fees of £200 have been borne by another group undertaking.

2. Directors' remuneration

The directors' remuneration was £nil (2013 – £nil).

The directors of the company are also directors of a number of subsidiaries of the ultimate parent undertaking. The directors do not believe that it is practicable to apportion the remuneration between remuneration as directors of the company and their remuneration as directors of the fellow subsidiary companies. The directors' remuneration is therefore disclosed in the accounts of the subsidiaries that make the remuneration payments.

3. Staff costs

The company has no employees other than directors.

4. Profit and loss account

The company has not traded during the year and has made neither a profit nor a loss. No profit and loss account has therefore been prepared.

5. Profit on ordinary activities before taxation

Under the terms of the agreement entered into with Warner/Chappell Music Limited dated 1 July 1997, Warner/Chappell Music Limited is responsible for the payment of all costs and expenses of the company.
