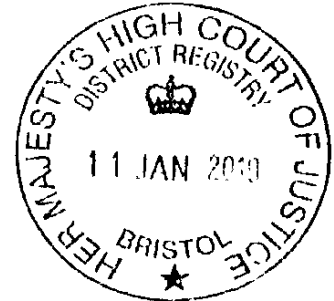

UPON THE APPLICATION of the Applicants for a block transfer order under Chapter 6 (Sub-division B) of Part 12 of the Insolvency (England and Wales) Rules 2016  
AND UPON READING the evidence

IT IS ORDERED THAT:
