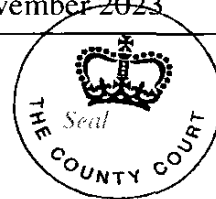

**UPON THE APPLICATION** by a Claim Form dated the 23RD January 2023 of Katie Mullarkey the Claimant and a member and director of the above named Peter O'Sullivan Meats Limited (hereinafter called "the Company")

**AND IT APPEARING** that there is no opposition on behalf of His Majesty to the relief sought by this Claim as appears from the Evidence of Service of and the exhibit thereto

**AND** on the Claimant undertaking that:

- (A) transfer from its ownership a parcel of land situate at and known as Land lying to the West of Rosewood Woodrow Lane, Great Moulton, Norwich, NR15 2DR registered with His Majesty's Land Registry under Title Number NK494688 referred to in paragraph 12 and 13 of the Witness Statement of Katie Marie Mullarkey dated the 19th January 2023 (the action) according to law
- (B) she will notify the Registrar of Companies within 14 days of the conclusion of the action
- (C) the director of the company will within 14 days of the expiry of 3 months from the conclusion of the action apply to the Registrar of Companies for the voluntary strike off of the company under Section 1003 of the Companies Act 2006 and comply with all the relevant requirements for such an application

**AND UPON** the Solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order

## BY CONSENT IT IS ORDERED THAT:

- (1) the name of the above named Peter O'Sullivan Meats Limited be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 01428076 Limited
