**ORDER**

---

**UPON THE APPLICATION** by a claim form dated 9 November 2021 of Martin Frederick Peter Smith and Nicola Joanne Meadows, the former joint liquidators of the above-named Stoneleigh Park Limited (hereinafter "the Company")

**AND UPON** reading the evidence including statements filed with the Court by the Claimants to the effect that they are both insolvency practitioners qualified to act as the joint liquidators of the Company and that they consent to act accordingly

**AND IT APPEARING** that there is no opposition on behalf of Her Majesty to the relief sought by this claim as appears from the evidence of service of Stuart Andrew Turner dated 2 December 2021 and the exhibit thereto

**IT IS ORDERED THAT**

1. The above-named Stoneleigh Park Limited be restored to the register of companies.
2. The Company do continue in members' voluntary liquidation.
3. If at the date of registration of this order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall, pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 ("the Act") change the name of the Company to 01431132 Limited.
4. An office copy of this order be delivered to the Registrar of Companies and pursuant to the Section 1032 of the Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off.

5. The Registrar of Companies do advertise notice of this order in her official name in the London Gazette.
6. The Claimants, having filed statements confirming that they are qualified to act as insolvency practitioners in relation to the Company and having consented to act accordingly, are appointed joint liquidators of the Company from the date on which the Company is restored to the register of companies, pursuant to Section 108 of the Insolvency Act 1986 ("the IA86").
7. Pursuant to Section 231 of the IA86 any act required or authorised under any enactment to be done by the liquidator of the Company may be done by all or any one or more of the Claimants.
8. Pursuant to Rule 18.7(5) of the Insolvency (England & Wales) Rules 2016, for the period commencing on 15 January 2019, being the date on which the former liquidators' final account was delivered to the Company's members pursuant to Section 94 of the IA86, to the date on which the Company is restored to the register of companies, the Claimants are not required to produce and deliver progress reports to the Company's members.
9. The Claimants do pay the Registrar of Companies her costs of the said application in the agreed sum of £300.00.
