
Ernst & Young LLP have expressed their willingness to continue in office as auditors and a resolution proposing their re-appointment will be submitted at the Annual General Meeting.

STATEMENT OF DIRECTORS' RESPONSIBILITIES IN RESPECT OF THE FINANCIAL STATEMENTS

The directors are responsible for preparing the annual report and financial statements in accordance with applicable laws and regulations (United Kingdom Generally Accepted Accounting Practice).

Opinion

We have audited the financial statements of "The Championship Committee" Merchandising Limited (the 'company') for the year ended 31 December 2017 which comprise the Statement of Income and Retained Earnings, the Statement of Financial Position and the related notes 1 to 6, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards including FRS 102, The Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

Responsibilities of directors



1. ACCOUNTING POLICIES

Statement of compliance

“The Championship Committee” Merchandising Limited is a limited liability company registered in England.

The company’s financial statements have been prepared in accordance with FRS 102 as it applies to financial statements of the company for the year ended 31 December 2017.

The Company has taken advantage of the exemption allowed by FRS 102 for small companies from preparing a Statement of Cash Flows.

Basis of preparation

The financial statements have been prepared in accordance with applicable accounting standards. These financial statement have been prepared in accordance with FRS102 “The Financial Reporting Standard applicable in the UK and Republic of Ireland” (FRS 102) and the requirements of the Companies Act 2006 as applicable to companies subject to the small companies regime. The disclosure requirements of section 1A of FRS 102 have been applied other than where additional disclosure is required to show a true and fair view.

The financial statements of “The Championship Committee” Merchandising Limited were approved by the Board of Directors on 9 March 2018.

Consolidated Accounts

As the Company and its subsidiary are both small companies, advantage has been taken of the exemption allowed by Section 398 of the Companies Act 2006 from preparing consolidated accounts.

Foreign Currencies

Assets and liabilities denominated in foreign currencies are translated at the rate of exchange ruling at the balance sheet date. Transactions in foreign currencies are recorded at the rate of conversion to sterling.

All differences are taken to the income statement.

Fixed Assets

Fixed assets are carried at cost less impairment.
