

PRELIMINARY

- 1. In these Articles (a) words defined in the Memorandum of Association shall have the same meaning (b) "Owner" means the Lessee for the time being of a Flat under a Lease derived immediately out of the freehold interest in the Property (c) words importing the singular number only include the plural number and vice versa.
- 2. Except and subject as hereinafter expressly or by necessary implication provided, the regulations contained or incorporated in Part I and Part II of Table A in the First Schedule to the Companies Act 1948 as amended by the Companies Acts 1967 to 1976 (hereinafter referred to as "Table A") except Clauses 3 and 4 of Part II snall apply to the Company.
- 3. In addition of the clauses excluded in Part II of Table A the following clauses are also excluded namely: Clauses 2 -6 (inclusive) 11 22 (inclusive) 33 46 (inclusive) 75 78 (inclusive) 87, 89, 90, 107 109 (inclusive) 114 122 (inclusive) 128 and 129 of Part I of Table A.

 - (A) In clause 79 the proviso to that clause were deleted.
 - (B) In clause 84 sub-clause (2) was deleted.
 - (C) In clause 92 the words "in manner aforesaid" were deleted.

SHARES

- 5. (a) No Owner shall be registered as the holder of more than one share for each Flat of which he is the Owner.
