

NOTES TO THE FINANCIAL STATEMENTS

YEAR ENDED 31 DECEMBER 2016

1. ACCOUNTING POLICIES

Company information

W.O.W Campaigns Limited is a private company limited by shares incorporated in England and Wales. The registered office is 44-48 Shepherdess Walk, London, N1 7JP.

1.1 Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with Section 1A of FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the requirements of the Companies Act 2006 as applicable to companies subject to the small companies regime.

The financial statements are prepared in sterling, which is the functional currency of the company. Monetary amounts in these financial statements are rounded to the nearest pound.

These financial statements for the year ended 31 December 2016 are the first financial statements of W.O.W Campaigns Limited prepared in accordance with FRS 102, The Financial Reporting Standard applicable in the UK and Republic of Ireland.

The date of transition to FRS 102 was 1 January 2015. The financial position and performance for the previous period is not affected by the transition to FRS102.
