1 Why this report has been prepared

- 1.1 As you will be aware Anne O'Keefe, Peter Saville and Simon Freakley (the **Liquidators**) were appointed on 30 October 2013
- 1.2 In accordance with UK insolvency legislation, a liquidator is required to provide a progress report covering the period of 12 months commencing on the date on which a company entered into liquidation and every subsequent period of 12 months. This progress report covers the period 30 October 2014 to 29 October 2015 (the **Period**) and this report should be read in conjunction with all previous reports
- 1.3 This report has been prepared in accordance with rule 4 49C of the Insolvency Rules 1986.
- 1.4 The purpose of this report is to provide statutory and financial information about the Company and to provide an update on the progress of the Liquidation, including details of assets realised during the Period, details regarding the Liquidators' fees and the expected outcome for each class of creditor.
- 1.5 Details of the Liquidators' fees and costs incurred are detailed at Appendix C to G
- 1.6 More information relating to the Liquidation process, Liquidators' fees and creditors' rights can be found on AlixPartners' creditor portal (<http://www.alixpartnersinfoportal.com>). Log-in details to access this information can be found within the covering letter you have received

Secured creditor

Barclays Bank PLC (Barclays) acting as security agent for Lakeshore Lending Limited (Lakeshore) holds fixed and floating charges registered against the Company and other group entities across the Clintons group. Barclays were owed approximately £36.9 million (including accrued interest and charges) on appointment.

A total of £10.4 million has been distributed during the course of the Liquidation of the Company, with £26.5 million having been distributed in the preceding Administration and from other group companies.

Preferential creditors

All proving preferential creditors were paid in full in the preceding Administration.

The Liquidators received a further preferential claim of £48 which was paid in full on 11 September 2014. No further claims are expected.

Unsecured creditors

In respect of the unsecured creditors, UK insolvency legislation stipulates that creditors of the same class should be treated equally. Hence the funds available for distribution are split on a pro-rata basis amongst all creditors of this class, regardless of the size of their claims.

The estimated debt of the unsecured creditors has been taken from the directors' Statement of Affairs (SOA), which was provided in the former Administration. To date, the Liquidators have received claims from 1,536 creditors totalling £68.7 million.

A dividend will be available to the unsecured creditors but the timing of the distribution is currently uncertain. The Liquidators estimate that the dividend distribution will be between 2.5 and 3 pence in the pound.

For further information please refer to section 4 of this report.

3 Progress of the Liquidation

- 3 1 Attached at Appendix B is the Liquidators' Receipts and Payments Account for the Period, together with a Cumulative Account for the period since appointment.

Freehold land and property

- 3 2 As detailed in the Liquidator's last annual report, the Liquidators finalised a sale of the head office for £8.6 million, with a deferred element of £250,000 in respect of land for which an adverse possession application for title was ongoing
- 3 3 The adverse possession application was finalised on 28 January 2015 and the deferred sum of £250,000 was received from the purchaser, Sytner Limited

Rates refund

- 3 4 As previously advised, Consultiam Property Limited (CAPA), continue to pursue possible rates refunds. During the Period, a total of £100,867 has been received. The Liquidators are unable to confirm the quantum of future rates refunds as these are now received on an adhoc basis. Any future refunds will be available, subject to the cost of realisations, for the unsecured creditors of the Company.

Book debts

- 3 5 As stated in the annual report, BRE Realisations Limited (formerly Birthdays Retail Limited) – in Liquidation (Birthdays) owed the Company £16.2 million. There will be a dividend available for the unsecured creditors of Birthdays which is currently estimated at one pence in the pound. The timing of this dividend is uncertain.

Game liability

- 3 6 As detailed in the last progress report, the Supreme Court refused permission to appeal the ruling in Pillar Denton Ltd and others v Jarvis and others (2014) (the Game Ruling), therefore in certain circumstances, landlords may have a claim relating to any beneficial occupation of a property by the Company during the period following appointment of the former Administrators
- 3 7 The Liquidators conducted a detailed review of all properties used during the trading period of the former Administration to see what the potential outstanding liability there could be for the Administration.
- 3 8 The Liquidators, reviewed the rent already paid by the Company prior to the Administrators' appointment, any rent free agreements agreed with landlords, any rent which was paid by the Administrators and any property surrenders which were agreed
- 3 9 The Liquidators' review found that there was a potential £1.1 million liability in respect of 476 stores. Based on legal advice and Counsel's opinion, the Liquidators contacted all the landlords where there was a potential liability inviting them to confirm whether there was an outstanding claim. Where applicable, payment has subsequently been made as an expense of the former Administration. To date, payments totaling £367,284 have been made
- 3.10 The Liquidators are currently in the process of submitting an application to court to receive directions on how to proceed with finalising the Liquidation and distributing the Company's remaining assets to its unsecured creditors. A final update will be provided in the next report.

Other assets

- 3 11** All funds received in the Liquidation are held on interest bearing accounts and a total of £28,630 has been realised in respect of bank interest during the Period
- 3 12** Sundry realisations totalling £2,931 have also been received in the Period
- 3 13** A rent refund of £19,780 was received by the Liquidators of a sub-tenant on 19 February 2015.

4 Estimated outcome for creditors

Secured creditor – Lakeshore Lending Limited

- 4 1** As previously advised, Barclays, acting as security agent for Lakeshore, held fixed and floating charges which were registered against the Company and across the Clintons group. They were owed approximately £36.9 million (including interest and charges)
- 4 2** During the course of the Liquidation, £10.4 million has been distributed to the secured creditor. Funds totalling £26.5 million were distributed in the preceding Administration and from the other companies in the Clintons group
- 4 3** Lakeshore has confirmed that all funds have been paid and its debt has been discharged in full, including all interest and charges

Preferential creditors

- 4 4** The preferential creditors were paid in full in the former Administration.
- 4 5** A further preferential claim was brought to the attention of the Liquidators and the creditor was paid in full on 11 September 2014. No further claims are anticipated

Unsecured Creditors' Fund

- 4 6** Where there is a floating charge which was created on or after 15 September 2003, the Liquidators are required to create a fund from the Company's net property available for the benefit of unsecured creditors (**Unsecured Creditors' Fund**), commonly known as the 'Prescribed Part'.
- 4 7** As Lakeshore has been paid in full, there is no requirement to set aside the Unsecured Creditors' Fund as all surplus funds will be available for the benefit of the unsecured creditors

Unsecured creditors

- 4 8** Based on the SOA the unsecured creditors are estimated to be approximately £88 million. The Liquidators have reviewed 1,536 claims to date and have agreed claims totalling £68.7 million
- 4 9** The Liquidators can confirm that there will be funds available to the unsecured creditors. The funds are estimated to be in the region of £2.9 million, however this is dependant on finalisation of any further rental payments due under the Game Ruling
- 4 10** Based current information, an estimated dividend of between 2.5 and 3 pence in the pound will be available to the Company's unsecured creditors.
- 4 11** Details of the claims the Liquidators have received to date and the status of such claims can be found in Appendices H to J. If you do not find your name in the attached schedules you should conclude that the Liquidators have not received a claim from you. Should you wish to submit a claim in the Liquidation, please complete the statement of claim form which can be found on at Appendix K and send the completed form, together with sufficient backing documentation by email to clintonscreditors@alixpartners.com or by post for the attention of Katie Wells at the Company's registered office detailed at Appendix A.
- 4 12** Should there be any changes to the claim you have submitted, please contact the Liquidators as soon as possible with details of the changes.

- 4 13 It should be noted that in the spreadsheets attached at Appendices H to J any addresses for individuals have been changed to c/o the Company's registered office. This is to comply with The Data Protection Act 1998
- 4 14 All employee unsecured claims have been agreed in accordance with the RP1 forms completed by the employees in the preceding Administration. If you wish to confirm the quantum of your unsecured claim, please send a request by email to clintonscreditors@alixpartners.com

Unclaimed dividends

- 4 15 All cheques paid to preferential creditors in the Administration should have been banked. Any cheques which have not cleared have been cancelled and the proceeds have been forwarded to The Insolvency Service, Estate Accounts Directorate, Unclaimed Monies Team, PO Box 3690, Birmingham, B2 4UY.
- 4 16 If your cheque has been cancelled, please submit a claim to the Insolvency Service by contacting the Insolvency Service by email at eaips.unclaimed@insolvency.gsi.gov.uk and put CCE Realisations Limited – in Liquidation as the subject.
- 4 17 The transfer of responsibility to the Insolvency Service is a routine step which requires Liquidators of an insolvent company to transfer unclaimed dividends to the agency six months after the cheques were issued. The agency will hold the funds for the subsequent six years, after which it will return any money that remains unclaimed to HM Treasury, however, this does not affect creditors' rights to claim funds after the six years has passed

5 What happens next

Creditors' rights

- 5 1 Within 21 days of the receipt of the report, a secured creditor, or an unsecured creditor (with the agreement of at least 5% of the value of the unsecured creditors) may request in writing that the Liquidators provide further information about their fees or expenses which have been itemised in this progress report.
- 5 2 Any secured creditor, or an unsecured creditor (with the concurrence of at least 10% of the value of unsecured creditors) may, within eight weeks of receipt of this progress report, make an application to court on the grounds that the basis fixed for the Liquidators' fees is inappropriate, or that the fees or the expenses incurred by the Liquidators as set out in this progress report are excessive

Next report

- 5 3 The Liquidators are required to provide a progress report within two months of the end of the next year of the Liquidation. If the Liquidation has been completed before then, a final meeting will be called, and a draft report circulated before that meeting.

- Realisation of assets fixed charge – reviewing and updating the realisation strategy, managing the adverse possession application and finalising the sale of the head office
- Realisation of assets floating charge - monitoring and updating the impact of the Game Ruling, completing a full review of all potential landlord claims, communicating with landlords and dealing with all queries Time spent reviewing and processing all payments to landlords in line with the recent case law and processing the payments has also been recorded Time dealing with the court application in order to finalise the Game Ruling liability and reviewing all documentation in relation to the court application has been recorded in this section Time has also been spent liaising with the landlord and utility agents in respect of the disclaimed leases and other queries. Dealing with updates from CAPA and payments in relation to rates refunds is also recorded in this section.
- Creditors – time has been spent reviewing all creditor correspondence, agreeing claims where possible and ensuring that creditor lists are up to date and accurate Time has also been spent dealing with general queries from employees and unsecured creditors Updating and finalising the secured creditor position has also been recorded in this section Time has also been spent reporting to the general body of creditors and dealing with the distribution to the secured creditor

Where a company which is in administration moves into winding up under paragraph 83 of schedule B1 to the Insolvency Act 1986, and the administrator becomes the liquidator, the basis of fees fixed in the administration automatically applies in the subsequent liquidation by virtue of rule 4.127(5A) of the Insolvency Rules 1986. The basis agreed is by reference to the time properly spent by the liquidators and their staff on matters arising in the Liquidation.

To date, fees of £426,537 have been drawn on account.

Disbursements

Category 1 disbursements of £11,018 have been drawn on account. Approval to draw category 2 disbursements was given by the secured and preferential creditors in the former Administration and £1,437 have also been drawn in relation to the below

- Photocopying – charged at the rate of 10 pence per sheet for notifications and reports to creditors and other copying.
