## SECURITY ACCESSION DEED

THIS SECURITY ACCESSION DEED is made on 21 December 2022

### BETWEEN:

- (1) **THE PERSONS** listed in Schedule 1 (*The Additional Chargors*) each an "Additional Chargor" and together the "Additional Chargors";

In favour of:

- (2) **GLOBAL LOAN AGENCY SERVICES AUSTRALIA NOMINEES PTY LIMITED ACN 608 945 008** as the trustee for each of the Beneficiaries (the "Security Trustee").

### RECITAL:

This Security Accession Deed is supplemental to a debenture dated 24 September 2022 between (amongst others) Ludgate Limited as the Original Chargor and the Security Trustee (the "General Security Agreement").

This Security Accession Deed is a Secured Document and a Transaction Security Document for the purposes of the Facility Agreement.

**NOW THIS SECURITY ACCESSION DEED WITNESSES** as follows:

## 1 INTERPRETATION

### 1.1 Definitions

Save to the extent otherwise defined in this Security Accession Deed, terms defined in the General Security Agreement have the same meaning when used in this Security Accession Deed.

In this Deed:

"Account" means each of the accounts opened or maintained by any Chargor with any bank, building society, financial institution or other person (including any renewal, redesignation, replacement subdivision or subaccount of such account but excluding the Excluded Accounts) and the debt or debts represented thereby including the accounts specified in Schedule 7 (*Accounts*) and including all Related Rights.

"Excluded Accounts" means the accounts detailed in Schedule 10 (*Excluded Accounts*).

### 1.2 Construction

Clause 1.2 (*Construction*) of the General Security Agreement shall be incorporated into this Deed as if set out in full in this Deed and as if references in that clause to "the General Security Agreement" were references to this Security Accession Deed.

## 2 ACCESSION OF NEW CHARGING COMPANIES

### 2.1 Accession

Each Additional Chargor agrees to be a Chargor for the purposes of the General Security Agreement with immediate effect and agrees to be bound by all of the terms of the General Security Agreement as if it had originally been a party to it as a Chargor.

## 2.2 **Covenant to pay**

Each Additional Chargor covenants with the Security Trustee that it shall, on demand of the Security Trustee pay, discharge and satisfy the Secured Obligations and indemnify the Security Trustee and the other Beneficiaries against any losses, costs, charges, expenses and liabilities arising from any breach or failure to pay, discharge and satisfy the Secured Obligations in accordance with their respective terms.

## 3 **FIXED SECURITY**

### 3.1 **Mortgage of Real Property**

Each Additional Chargor charges, by way of legal mortgage its Mortgaged Property.

### 3.2 **Fixed charge over Real Property**

Each Additional Chargor charges (to the extent not validly and effectively charged by way of first legal mortgage pursuant to Clause 3.1 (*Mortgage of Real Property*)), by way of first fixed charge, all of its right, title and interest from time to time in and to all its Real Property.

### 3.3 **Fixed charge over Accounts**

Each Additional Chargor charges, by way of first fixed charge, all of its rights, title and interest from time to time in and to all its Accounts.

### 3.4 **Fixed charge over Intellectual Property**

Each Additional Chargor charges, by way of first fixed charge, all of its rights, title and interest from time to time in and to all its Intellectual Property.

### 3.5 **Fixed charge over Investments**

Each Additional Chargor charges, by way of first fixed charge, all of its rights, title and interest from time to time in and to all its Investments.

### 3.6 **Fixed charge over Monetary Claims**

Each Additional Chargor charges, by way of first fixed charge, all of its rights, title and interest from time to time in and to all its Monetary Claims (other than any claims which are otherwise subject to a fixed charge or assignment (at law or in equity pursuant to this Deed) (to the extent not already charged under this Clause 3.6).

### 3.7 **Fixed charge over Shares**

Each Additional Chargor charges, by way of first fixed charge, all of its rights, title and interest from time to time in and to all the Shares owned by it.

### 3.8 **Fixed charge over Tangible Moveable Property**

Each Additional Chargor charges, by way of first fixed charge, all of its rights, title and interest from time to time in and to all its Tangible Moveable Property.

### 3.9 **Fixed charge over contracts**

Each Additional Chargor charges, by way of first fixed charge, all of its rights, title and interest from time to time in and to any contract or agreement to which such Additional Chargor is a party (except for the Specified Contracts).

**3.10 Fixed charge over goodwill**

Each Additional Chargor charges, by way of first fixed charge, all of its rights, title and interest from time to time in and to any goodwill, rights and claims in relation to the uncalled capital of such Additional Chargor.

**3.11 Fixed charge over other assets**

Each Additional Chargor charges (to the extent not validly and effectively charged by way of legal mortgage pursuant to Clause 3.1 (*Mortgage of Real Property*)), by way of first fixed charge, all of its rights, title and interest from time to time in and to each Insurance Policy and each Specified Contract of such Additional Chargor in relation to each of those assets.

**3.12 Assignment of Insurance Policies**

Each Additional Chargor assigns and agrees to assign absolutely, all of its rights, claims, title and interest from time to time in and to each Insurance Policy of such Additional Chargor.

**3.13 Assignment of Specified Contracts**

Each Additional Chargor assigns and agrees to assign absolutely, all of its rights, claims, title and interest from time to time in and to each Specified Contract of such Additional Chargor.

**4 FLOATING CHARGE**

- (a) Each Additional Chargor charges by way of first floating charge in favour of the Security Trustee all of its present and future assets, undertaking and rights of that Additional Chargor, but excluding any sums standing to the credit of the Excluded Accounts from time to time.
- (b) The floating charge created pursuant to paragraph (a) above:
  - (i) shall be deferred in point of priority to all Fixed Security validly and effectively created by such Additional Chargor under the Secured Documents in favour of the Security Trustee as security for the Secured Obligations; and
  - (ii) may not be converted into a fixed charge solely by reason of:
    - (A) the obtaining of a moratorium; or
    - (B) anything done with a view to obtaining a moratorium,
 under Part A1 of the Insolvency Act 1986.
- (c) The floating charge created pursuant to paragraph (a) above is a **qualifying floating charge** for the purpose of paragraph 14 of schedule B1 to the Insolvency Act 1986.

**5 NEGATIVE PLEDGE**

Each Additional Chargor may not, at any time during the Security Period:

- (a) create or agree to create or permit to subsist any Security or Quasi-Security over all or any part of its assets;
- (b) either in a single transaction or in a series of transactions and whether related or not and whether voluntarily or involuntarily, dispose of or purport to dispose of all or any part of its assets;

- (c) without the prior consent of the Security Trustee declare a trust of, create or purport to create or permit to arise or subsist (including granting any option) any lease, licence, interest or right to occupy in favour of, or share possession of, any of its Real Property with any third party; or
- (d) do or cause or permit to be done anything which may in any way jeopardise or otherwise prejudice the Security created or intended to be created by this Security Accession Deed,

in each case, unless expressly permitted under and in accordance with the Facility Agreement or otherwise with the prior consent of the Security Trustee.

## 6 CONSTRUCTION OF DEBENTURE

- (a) The General Security Agreement and this Security Accession Deed shall be read together as one instrument on the basis that:
  - (i) references in the General Security Agreement to "**this Deed**" or "**this Agreement**" and other similar expressions will be deemed to be references to the General Security Agreement as supplemented by this Security Accession Deed; and
  - (ii) where the General Security Agreement requires a Chargor to perform an obligation "on the date of this Agreement" the Additional Chargor shall perform that obligation on the date of this Deed.
- (b) This Security Accession Deed is supplemental to the General Security Agreement and the General Security Agreement remains in full force and effect.

## 7 SECURITY ASSETS

- (a) The fact that no or incomplete details of any Security Assets are inserted in the Schedules or in the schedules to any Security Accession Deed by which a Chargor became party to the General Security Agreement does not affect the validity or enforceability of the General Security Agreement.
- (b) With respect to Risk Transfer Group Limited only, Security Assets shall not include any assets with legal situs outside of the United Kingdom.

## 9 GOVERNING LAW

This Security Accession Deed and any non-contractual obligations arising out of or in connection with it are governed by English law.

10 **SERVICE OF PROCESS**

- (a) Without prejudice to any other mode of service allowed under any relevant law, Risk Transfer Group Limited:
  - (i) irrevocably appoints the Original Chargor as its agent for service of process in relation to any proceedings before the English courts in connection with this Deed; and
  - (ii) agrees that failure by a process agent to notify it of the process will not invalidate the proceedings concerned.
- (b) If any person appointed as an agent for service of process is unable for any reason to act as agent for service of process, Risk Transfer Group Limited must immediately (and in any event within 3 Business Days of such event taking place) appoint another agent on terms acceptable to the Security Trustee.
- (c) Failing this, the Security Trustee may appoint another agent for this purpose.

**THIS DEED** has been executed and delivered as, and is intended to take effect as, a deed by each Additional Chargor and has been signed by the Security Trustee on the date stated at the beginning of this Deed.




