- 2. THAT the articles of association be amended by the deletion of the existing Article 12.1 and the substitution therefor of the following new Article 12.1:
 - Any director (other than an alternate director) (the Appointor) may appoint 12.1 any Qualifying Person, to be an alternate director to exercise the Appointor's powers, and carry out the Appointor's responsibilities, in relation to the taking of decisions by the directors, in the absence of the Appointor. In these Articles, where the context so permits, the term "P Director" or "B Director" or "K Director" or "R Director" shall include an alternate director appointed by a P Director or a B Director or a K Director or an R Director (as the case may be). A person may be appointed an alternate director by more than one director provided that each of his Appointors represents the same class of shares but not otherwise.
