AND UPON the Claimant Investec Group (UK) Limited (in Members' Voluntary Liquidation and acting by its Liquidator Lawrence John King) undertaking that they will

within 21 days of it being made serve on the Registrar of Companies a copy of the Order under Section 108 of the Insolvency Act 1986 appointing a Liquidator

UPON the solicitors for the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

## IT IS ORDERED THAT:

- (1) the name of the above named Guinness Mahon Pension Fund Trustees

  Limited be restored to the Register of Companies
- (2) the Company do continue in Members' Voluntary Liquidation
- (3) the Claimant do serve a copy of the Order on the Company's former liquidator within 21 days of the date hereof
- (4) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 01524848 Limited
- (5) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off

- (6) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"
- (7) the hearing on 11 October 2022 shall be vacated
