1. INTRODUCTION

I refer to the appointment of Simon Harris and I as Joint Liquidators of Country Grill Restaurants Limited (the Company) on 12 January 2017.

This is my final account to the member as all matters have now been concluded and the Liquidation can now be finalised.

The Company's statutory information is detailed at **Appendix I**.

2. LIQUIDATORS' ACTIONS SINCE APPOINTMENT

The following actions have been undertaken since my appointment and up to the previous reporting period:

- Upon appointment I arranged for the formal notices to be issued to the relevant parties
- An in specie distribution was declared to the member of the Company on 25 April 2017 regarding the shares held, and
- Dealt with HM Revenue & Customs (HMRC) for pre-appointment taxation clearances.

The following actions have been undertaken during the reporting period (12 January 2018 to 11 December 2018):

- Prepared and circulated my annual report to the member on 7 March 2018
- Prepared the draft final account and this final account, and
- Took steps to finalise the liquidation.

The matters undertaken during the course of the solvent liquidation process have been statutory in nature and whilst there is no direct benefit to the member, the work has been completed under a fixed fee agreement.

3. RECEIPTS AND PAYMENTS

Attached at **Appendix II** is the receipts and payments account for the period 12 January 2017 to 11 December 2018.

4. ASSETS

The Declaration of Solvency indicates the Company has two assets being an investment in Country Fayre Restaurants Limited for £5 and a debtor balance of £2 due from The Chef & Brewer Group Limited.

The debtor balance was in specie distributed to the member on 25 April 2017, leaving no further assets to realise. The investment is discussed below.

5. LIABILITIES

The Declaration of Solvency indicated that an amount of £5 was due to Country Fayre Restaurants Limited which upon receipt of the capital distribution from Country Fayre Restaurants Limited, the liability was cleared and the investment listed as an asset was reduced to nil. No other liabilities have been identified during the Liquidation.

6. DISTRIBUTION TO THE MEMBER

On 25 April 2017, I distributed £2 in specie to the member of the Company by way of a first and final distribution of capital at a rate of £0.10 per ordinary share.

There will be no further distributions to the member

7. JOINT LIQUIDATORS' REMUNERATION AND EXPENSES

Written resolutions of the member dated 12 January 2017 resolved that the Joint Liquidators' remuneration should be fixed at £1,875 plus disbursements plus VAT for assisting with the

preparation of the Declaration of Solvency and the winding up of the Company. The amount has been paid in full by Greene King PLC.

The following disbursements have been incurred and paid:


