Notes to the financial statements

1. Transition to FRS 105

This is the first year that FRS105 has been adopted by the company. The company transition to FRS105 on 1st July 2015. On transition to FRS105, a transitional adjustment was required in relation to deferred tax which had been provided for previously. Deferred tax is not recognised under FRS105. This has resulted in an increase in reserves upon transition of £10,836 and a decrease in reserves of £1,973 at 30/06/16.

On transition an adjustment was also required to reallocate creditors due in more than one year to due in less than one year as required under FRS105 this has had no effect on reserves.

No further adjustments required on transition.

2. Accounting basis and standards
