The company was dormant throughout the year ended 30 June 2010.

For the year ended 30 June 2010 the company was entitled to exemption under section 480(1)(b) of the Companies Act 2006.

The members have not required the company to obtain an audit in accordance with Section 476 of the Companies Act 2006.
