

3 Pre Appointment expenses

- Pre administration costs unpaid at the date of the appointment of the administrators may be approved under Rule 2 67A to rank as an expense of the administration
- 3 2 Actual time costs for the pre appointment work undertaken amounted to £164,344 £20,000 was paid to Grant Thornton UK LLP prior to my appointment leaving a remaining unpaid balance of £144,344
- My pre appointment costs have not yet been approved. The secured creditors have been requested to approve my pre appointment costs. Once approval is gained I will request the same from the preferential creditors.

4 Progress Report

Summary of proposals

- The administrators have pursued the objective of a better result for creditors as a whole than would be likely if the companies with the Group were wound up. The proposals were submitted on 5 August 2010 and are deemed to have been approved on 17 August 2010.
- 42 It was proposed that the administrations will end by the administrators filing a notice to dissolve the companies within the Group, or if more time is needed to complete realisations after any extensions of the administration, the administrators may present a petition to wind

up the companies within the Group and seek their appointment as liquidators

Realisation of assets

- 4.3 My progress report of the first six months of the administration dated 12 January 2011 provides details of the sale of the business and assets of certain divisions with the Group and the sale of the remaining chattel assets
- Barcud's freehold property in Caernarfon and Glasgow are being marketed by my property agents, DTZ Debenham Tie Leung Limited (DTZ)
- 45 Barcud's freehold property in Caernarfon consists of Units 4 15 and The Television Studio at Cibyn Industrial Estate. I have accepted an offer to sell the Television Studio DTZ has been instructed to manage the estate and to market the remaining units to increase occupancy and to sell as investment properties.
- 46 DTZ are managing the freehold property in Barcud and are collecting rent from tenants as it falls due DTZ has not accounted to me for rent paid as it is holding the funds in order to fund the work required on the estate Rent collected to date amounts to £17,460, which is not included in my receipts and payments account at Appendix 1
- 47 Barcud's freehold property in Glasgow consists of Dalintober Hall I agreed a six month licence to occupy with the purchasers of the business and assets of Scotland. The licence has now expired and I have agreed a five year lease with the purchaser. The property is being marketed as an investment property.
- 48 In order for me to conclude the realisation of the Group's freehold property I intend to request that the secured and preferential creditors consent to the extension of the administration for a further six months pursuant to paragraph 76(2) of Schedule B1 to the Insolvency Act 1986
- 4 9 The right title and interest that the Group had in certain investment productions have been sold for £4,000 plus 50% of all revenue over the next four years. I am yet to receive any further income from the investment productions

Secured creditors

- 4 10 There is a chattels mortgage in favour of Lombard over certain assets across the Group HSBC Bank Plc (the Bank) also holds a second charge over the assets subject to Lombard's chattel mortgage
- 4 11 The Bank holds a floating charge over the remaining chattel assets of the Group which takes priority over unsecured creditors except for the amounts set aside under Section 176A of the Insolvency Act 1986 in all companies except Barcud
- 4 12 The Bank holds a fixed charge over the freehold properties of Barcud in Caernarfon and Glasgow

- 4 13 The total liability to the Bank is circa £2,656,000
- The Group's book debts, with the exception of the book debts of Eclipse, are subject to a factoring agreement with HSBC Invoice Finance Limited (HIF). The Bank holds a charge over any surplus from book debt proceeds if HIF are repaid in full.
- 4 15 The Bank, Lombard and HIF all have cross guarantees across the Group
- 4 16 The Bank's recovery is heavily reliant on the realisation of property, but it is expected that it will face a significant shortfall
- 4 17 All of the chattel assets subject to Lombard's chattels mortgage have now been realised for a total of £264,788 I have requested Lombard to confirm the total debt due before I distribute under its charge
- 4 18 HIF are collecting the book debts without my assistance, and at this stage it is unclear whether any surplus will arise

Preferential creditors

- 4 19 I have now received the preferential claims from the Redundancy Payments Office, which has enabled me to calculate the total preferential claim of £172,000
- 4 20 I estimate that there will be sufficient assets to enable a distribution in full to the preferential creditors of Barcud, Derwen, Eclipse and Awen I estimate that a dividend of 73p in the \pounds will be paid to the preferential creditors when all costs have been agreed

Unsecured creditors

4 21 I do not anticipate that there will be surplus funds to pay a dividend to unsecured creditors

Discharge from liability

- Pursuant to paragraph 78 of Schedule B1 to the Insolvency Act 1986 I am requesting each secured creditor and preferential creditors whose debts amount to more than 50% of the preferential debts to consent to a six month extension of the administrations of the companies within the Group
- 4 23 It is possible that I will seek a court order to extend the administration of Barcud beyond six months in order to enable me to complete the realisation of Barcud's freehold property, or alternatively seek the appointment of liquidators
- 4 24 The following resolution for discharge from liability will be requested from secured and preferential creditors

The Joint Administrators be discharged from liability in accordance with paragraph 98 of schedule B1 to the Insolvency Act 1986 with effect from 14 days after they send their progress report to creditors

5 Administrators' Remuneration and Expenses

- 5 1 In accordance with Rule 2 106 of the Insolvency Act 1986, as I do not anticipate that a dividend will be paid to unsecured creditors in this matter, I will seek approval of my fees from the secured and preferential creditors
- Fre administration costs unpaid at the date of the appointment of the administrators may also be approved under Rule 2 67A to rank as an expense of the administration
- Actual time costs for the pre appointment work undertaken amounted to £164,344 £20,000 was paid to Grant Thornton UK LLP prior to my appointment leaving a remaining unpaid balance of £144,344
- Time costs of the administrations of all companies within the Group to date amount to £329,765, representing 1,478 hours at an average of £223 per hour. No fees have been drawn to date
- The Bank has agreed to my fee proposal to contribute £75,000 for my pre appointment time and a base cap of £100,000 of my post appointment time plus 10% of any recoveries above break-up value and 5% of debtor recoveries if HIF are repaid in full
- I have submitted a fee proposal to Lombard whereby it will contribute £45,000 towards my pre appointment time and my fees for the realisation of assets would be charged on the basis of a percentage of realisations above break-up value. I proposed that I would charge 5% above break-up value for the sale of the HD1 unit and 10% above break-up value for all other assets. My fee proposal is yet to be agreed and I am in discussions with Lombard.
- Attached at Appendix 3 is an analysis of the time costs to date for all of the administrations of the Group, excluding pre appointment time

Appendix 8 - An extract from the Insolvency Rules 1986 relating to creditors' rights to request additional information from the Administrators

Rule 2 48A

If (a) within 21 days of receipt of a progress report under Rule 2 47-

(1) a secured creditor, or

(ii) an unsecured creditor with the concurrence of at least 5% in value of the unsecured creditors (including the creditor in question), or

(b) with the permission of the court upon an application made within that period of 21 days, any unsecured creditor,

makes a request in writing to the administrator for further information about remuneration or expenses (other than pre-administration costs) set out in a statement required by Rule 2 47(1)(db) or (dc), the administrator must, within 14 days of receipt of the request, comply with paragraph (2)

- (2) The administrator complies with this paragraph by either (a)providing all of the information asked for, or(b)so far as the administrator considers that(i)the time or cost of preparation of the information would be excessive, or
 - (ii) disclosure of the information would be prejudicial to the conduct of the administration or might reasonably be expected to lead to violence against any person, or (iii) the administrator is subject to an obligation of confidentiality in respect of the information, giving reasons for not providing all of the information
- (3) Any creditor, who need not be the same as the creditor who requested further information under paragraph (1), may apply to the court within 21 days of—
 - (a) the giving by the administrator of reasons for not providing all of the information asked for, or
 - (b) the expiry of the 14 days provided for in paragraph (1), And the court may make such order as it thinks just
- (4) Without prejudice to the generality of paragraph (3), the order of the court under that paragraph may extend the period of 8 weeks provided for in Rule 2 109(1B) by such further period as the court thinks just "

Appendix 9 - An extract from the Insolvency Rules 1986 relating to creditors' rights to challenge the Joint Administrators' fees if excessive

Rule 2 109

- (1) Any secured creditor, or any unsecured creditor with either the concurrence of at least 10% in value of the unsecured creditors (including that creditor) or the permission of the court, may apply to the court for one or more of the orders in paragraph (4)
- (1A)Application may be made on the grounds that-
 - (a) the remuneration charged by the administrator,
 - (B) the basis fixed for the administrator's remuneration under Rule 2 106, or
 - (c) expenses incurred by the administrator,
 - is or are, in all the circumstances, excessive or, in the case of an application under subparagraph (b), inappropriate
- (1B)The application must, subject to any order of the court under Rule 2 48A(4), be made no later than 8 weeks after receipt by the applicant of the progress report which first reports the charging of the remuneration or the incurring of the expenses in question ("the relevant report")
- (2) The court may, if it thinks that no cause is shown for a reduction, dismiss it without a hearing but it shall not do so without giving the applicant at least 5 business days' notice, upon receipt of which the applicant may require the court to list the application for a without notice hearing. If the application is not dismissed, the court shall fix a venue for it to be heard, and give notice to the applicant accordingly.
- (3) The applicant shall, at least 14 days before the hearing, send to the administrator a notice stating the venue and accompanied by a copy of the application, and of any evidence which the applicant intends to adduce in support of it
- (4) If the court considers the application to be well-founded, it must make one or more of the following orders—
 - (a) an order reducing the amount of remuneration which the administrator was entitled to charge,
 - (b) an order fixing the basis of remuneration at a reduced rate or amount,
 - (c) an order changing the basis of remuneration,
 - (d) an order that some or all of the remuneration or expenses in question be treated as not being expenses of the administration,
 - (e) an order that the administrator or the administrator's personal representative pay to the company the amount of the excess of remuneration or expenses or such part of the excess as the court may specify,
 - and may make any other order that it thinks just, but an order under sub-paragraph (b) or (c) may be made only in respect of periods after the period covered by the relevant report
