**"Guarantee"** means the guarantee contained in clause 2 of the Agreement and the indemnity contained in clause 5 of the Agreement (and, in each case, any corresponding provision in any deed supplemental to this Agreement),

**"Principal"** means any of the Companies insofar only as it at any time owes money or has incurred liabilities (whether actual or contingent) to the Bank otherwise than pursuant to the terms of the Agreement,

**"Sterling"** means the legal currency for the time being of the United Kingdom
