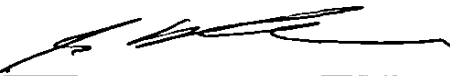

Details of progress

Receipts and payments Account

I attach a copy of my receipts and payments account for the period 27 September 2010, date of my appointment, to 12 May 2011.

Assets

The directors' declaration of solvency disclosed assets comprising an inter company debt of £80,000 due from Jewson Limited. This asset was distributed in specie to the shareholder on 30 December 2010.

Liabilities

There were no known liabilities.

Following their appointment, the liquidators gave notice by advertisement for creditors to submit details of their claims as required by statute. No such claims were received.

Tax Clearance

I have received formal tax clearance from H M Revenue & Customs for both the pre and post liquidation periods.

Liquidators' Fees and Disbursements

In accordance with our agreement with Saint Gobain Limited, the ultimate parent in the UK, the liquidators' fees and expenses in relation to winding up of the company are to be met by them

Dissolution

Following the final meeting of members, we will file a summary of the Liquidators' receipts and payments with the Registrar of Companies. The Company will be struck from the register three months thereafter.
