1 ACCOUNTING POLICIES

The principal accounting policies adopted in the preparation of the financial statements are set out below and have remained unchanged from the previous year

Basis of Preparation of Financial Statements

The full financial statements from which these abbreviated accounts have been extracted, have been prepared in accordance with the Financial Reporting Standard for Small Entities (effective January 2007) under the historical cost convention

The company has ceased operations, so the going concern basis is no longer considered appropriate. The full financial statements have therefore been prepared on a break up basis, though no material adjustments would have been necessary under the going concern basis.
