Pursuant to Chapter 2 of Part 13 of the Companies Act 2006 (the "Act"), the directors of the Company propose that the following resolutions be passed as special resolutions (the "Resolutions"):

SPECIAL RESOLUTIONS

- 1 "THAT, pursuant to Section 641(1)(a) of the Act, the share capital of the Company be reduced by £19,999,999, from £20,000,000, comprising 20,000,000 ordinary shares of £1.00 each; and to £1, comprising 1 ordinary share of £1.00, by cancelling and extinguishing 19,999,999 of such issued ordinary shares of £1.00 each.
- 2 "THAT the amount arising upon the reduction pursuant to Resolution 1 above be credited to the profit and loss reserves of the Company."

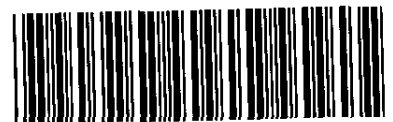

3. If you do not agree to any of the Resolutions, you do not need to do anything: you will not be deemed to agree if you fail to reply.
4. Once you have indicated your agreement to the Resolutions, you may not revoke your agreement.
5. Pursuant to section 642 of the Act, the Resolutions must be passed not more than 15 days after the date of the solvency statement relating to the reduction of capital (the date of such solvency statement being 2018), therefore unless sufficient agreement has been received for the Resolutions to be passed within 15 days after the date of the solvency statement, they will lapse. If you agree to the Resolutions, please ensure that your agreement reaches us before the end of this period.
