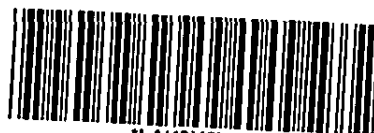

We have audited the financial statements of BELLS HILL (BARNET) MANAGEMENT COMPANY LIMITED for the year ended 31ST DECEMBER 2006 on pages five to nine which comprise of the Income & Expenditure Account, the Balance Sheet and the related notes.
