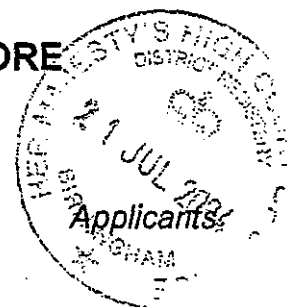

ORDER

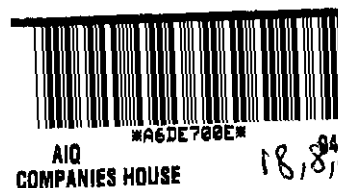
UPON THE APPLICATION of the Applicants

And UPON HEARING counsel for the Applicants

And UPON READING the evidence marked on the court file as having been read.

IT IS ORDERED that:

1)



- a) Pursuant to Section 41 (1) of the County Courts Act 1984 those Individual Voluntary Arrangements identified in the Schedule hereto as proceeding in the various County Courts therein stated be transferred to the Birmingham District Registry for the sole purpose of giving effect to paragraphs 1(b), 1(c), 9, 10, and 11 hereof;
- b) Pursuant to Section 263 (5) of the Insolvency Act 1986 Keith James Watkin be removed as the supervisor of the Individual Voluntary Arrangements identified in the Schedule hereto;

- c) Pursuant to Section 263 (5) of the Insolvency Act 1986 Christopher Humphrey Ison Moore be appointed as the supervisor of the said Individual Voluntary Arrangements in substitution for Keith James Watkin.

2)

- a) Pursuant to Rule 7.11 (4) of the Insolvency Rules and Section 41 (1) of the County Courts Act 1984 those Bankruptcy proceedings identified in the Schedule hereto as proceeding in the various County Courts therein stated be transferred to the Birmingham District Registry for the sole purpose of giving effect to paragraphs 2(b), 2(c), 9, 10, and 11 hereof;
- b) Pursuant to Section 298 (1) of the Insolvency Act 1986 Keith James Watkin be removed as the trustee of the estates of the persons identified in the Schedule hereto as having been made bankrupt;
- c) Pursuant to Section 303 (2) of the Insolvency Act 1986 Christopher Humphrey Ison Moore be appointed as the trustee of the said estates.

3)

- a) Pursuant to Section 41 (1) of the County Courts Act 1984 those Company Voluntary Arrangements identified in the Schedule hereto as proceeding in the various County Courts other than Birmingham District Registry therein stated be transferred to the Birmingham District Registry for the sole purpose of giving effect to paragraphs 3(b), 3(c), 9, 10, and 11 hereof;

- a) Pursuant to Section 19 (1) of the Insolvency Act 1986 Keith James Watkin be removed as administrator of the Administrations identified in the Schedule hereto as Dr. Chocolate Realisations Limited and Loxton & Wassall;
- b) Pursuant to Section 13 (2) of the Insolvency Act 1986 Christopher Humphrey Ison Moore be appointed as administrator of the said Administrations in substitution for Keith James Watkin;
- c) Pursuant to Paragraph 88 (1) of Schedule B1 to the Insolvency Act 1986 Keith James Watkin be removed as administrator of the Administration identified in the Schedule hereto as Atlas Access Group Limited;
- d) Pursuant to Paragraph 63 of Schedule B1 to the Insolvency Act 1986 Christopher Humphrey Ison Moore be appointed as administrator of the said Administration in substitution for Keith James Watkin

5)

- a) Pursuant to Section 108 of the Insolvency Act 1986 Keith James Watkin be removed as Liquidator of the companies identified in the Schedule hereto as being in Members' Voluntary Winding Up;
- b) Pursuant to Section 108 of the Insolvency Act 1986 Christopher Humphrey Ison Moore be appointed as Liquidator of the said companies.

6)

- a) Pursuant to Section 108 of the Insolvency Act 1986 Keith James Watkin be removed as Liquidator of the companies identified in the Schedule hereto as being in Creditors' Voluntary Winding Up;

b) Pursuant to Section 108 of the Insolvency Act 1986 Christopher Humphrey Ison Moore be appointed as Liquidator of the said companies save that he be not so appointed in respect of those companies where he is already a Liquidator jointly with Keith James Watkin.

7) The witness statement of Christopher Humphrey Ison Moore dated [] do stand as his statement for the purposes of Rule 4.103 of the Insolvency Rules.

8)

a) Pursuant to Rule 7.11 (4) of the Insolvency Rules and Section 41 (1) of the County Courts Act 1984 those winding up proceedings identified in the Schedule hereto as proceeding in the various County Courts therein stated be transferred to the Birmingham District Registry for the sole purpose of giving effect to paragraphs 8(c), 8(d), 9, 10, and 11 hereof;

b) Pursuant to CPR Part 30.2 (4) that winding up proceeding identified in the Schedule hereto as proceeding in the Royal Courts of Justice be transferred to the Birmingham District Registry for the sole purpose of giving effect to paragraphs 8(c), 8(d), 9, 10, and 11 hereof

c) Pursuant to Section 172 (2) of the Insolvency Act 1986 Keith James Watkin be removed as Liquidator of the companies identified in the Schedule hereto as being subject to a compulsory winding up order;

d) Pursuant to Section 168 (3) of the Insolvency Act 1986 Christopher Humphrey Ison Moore be appointed as Liquidator of the said companies.

9) Christopher Humphrey Ison Moore do within 28 days of the date of this Order cause to be placed in the London Gazette an advertisement listing the insolvency matters identified in the Schedule hereto and giving notice of the making of this Order. The said advertisement shall state that:

8A Any creditor who is affected by the Order shall have permission to apply to the Birmingham District Registry of the Chancery Division to vary or discharge the same within 28 days of the

- a) The effect of the Order is to remove Keith James Watkin from his position and to replace him with Christopher Humphrey Ison Moore;
- b) The reasons for the Order are the impending retirement of Keith James Watkin from KJ Watkin & Co and the desirability of ensuring continuity of management in the matters in question;
- c) Any creditor who is affected by the Order shall have permission to apply to the Birmingham District Registry of the Chancery Division to vary or discharge the same within **28** days of the date of the advertisement.



10) Keith James Watkin be at liberty to apply in relation to obtaining his release in respect of any of the matters listed in the Schedule hereto.

11) The costs of this Application be provided for as follows:

- a) such remuneration, costs, or expenses in respect of this Application as are referable to a particular matter in the Schedule shall be fixed and paid in the ordinary way as remuneration, costs, or expenses in respect of such matter;
- b) such remuneration, costs or expenses in respect of this Application as are not referable to a particular matter shall be assessed in the sum of **£15,530.00**, (inclusive of VAT to the extent that such VAT is not recoverable) and divided equally between the various matters in the Schedule and thereafter treated as costs or expenses of such matters;
- c) provided that in no circumstances shall the costs payable pursuant to this Order in relation to a particular matter exceed 10% of the value of the realised assets in that matter.
