

JOINT ADMINISTRATIVE RECEIVERS REPORT UNDER SECTION 48 OF THE INSOLVENCY ACT 1986

Enclosed is a notice of a meeting of creditors of Ken Moore Limited to be held on 5 March 1996.

My partner, W J Kelly, and I were appointed Joint Administrative Receivers to Ken Moore Limited on 30 November 1995 by the secured creditor, National Westminster Bank Plc. The appointment was made pursuant to a debenture dated 26 March 1993 giving fixed and floating charges over all of the assets of the company.

BACKGROUND TO APPOINTMENT

The business was founded in 1983 by Mr Ken Moore who built it into a profitable concern and then sold the shareholding to West Trust Plc in the late 1980's. During the early 1990's West Trust had a change of strategy and decided to divest their interest in textiles. As a result, the company, then Ken Moore Plc, was marketed for sale and eventually sold back to Mr Ken Moore to become a private limited company in late 1993.

The company knitted stretch fabrics for garment manufacturers predominately in the home market. The company operated from leasehold premises at Trent Park Industrial Estate and Barr Lane Industrial Estate, Nottingham.

During 1995 there was a marked decline in turnover part of which was anticipated by management, as the customer base was changing due to the imposing of minimum order quantities. During this period there had been significant staff reductions to accommodate the changes.

Whilst attempts were made to restructure the company suffered from cash flow problems. Discussions were entered into with major creditors in order to restructure the debts but ultimately were unsuccessful. As a result of this the directors requested the Bank to appoint an Administrative Receiver.

Accounts for the years ended 31 March 1994 and 31 March 1995 and the five month period ended 31 August 1995 show the following trading position:

DISPOSAL OF COMPANY'S ASSETS

Following the appointment of Joint Administrative Receivers the company continued to trade on a limited production schedule, whilst the business and assets were marketed for sale as a going concern. An advert was placed in the Financial Times on 5 December 1995 from which 32 enquiries were received. Four parties expressed further interest and visited the company's premises. On 12 January 1996 a sale of certain of the company's business assets was completed to Elastic Knitting (Northern Ireland) Limited.

DEBENTURE HOLDERS

The amount due to National Westminster Bank Limited as at 30 November 1995 was £466,859.

The company also factored its debts with Trade Indemnity-Heller Commercial Finance Limited and at the date of appointment the amount due to them was £369,016. West Trust Plc are owed £402,682 and hold a second charge by way of security.
