ORDER

BEFORE DISTRICT JUDGE TAYLOR

UPON THE APPLICATION of the Applicants dated 4th August 2022 for an order under Rule 12.36 of the Insolvency (England and Wales) Rules 2016 (the “Application”) (and the “Rules”) to remove the Respondent (the “Outgoing Office-holder”) from the insolvency offices held by him in the attached Schedule to this Order (together the “Insolvency Proceedings”) and to replace him as office-holder with the relevant Applicants as listed in the attached Schedule (the “Replacement Office-holders”).

UPON reading the evidence filed with the Application and no party being present or represented.

AND UPON the Court being satisfied that the Outgoing Office-holder is otherwise unable or unwilling to continue in office and that it is expedient to transfer all of the Insolvency Proceedings to the Replacement Office-holders and the Court noting that the Outgoing Office-holder consents to the terms of the Application.

AND UPON the Court being satisfied that the Replacement Office-holders are persons who are entitled to make an application under Rule 12.37(4)(b) or 12.37(4)(c) of the Rules and that the Replacement Office-holders are qualified to act as insolvency practitioners in relation to a company, a bankrupt or a debtor (as the case may be) and the Court noting that the Replacements Office-holders have consented to act in place of the Outgoing Office-holder.

AND UPON the Court being satisfied that notice of the Application was given to the Secretary of State in accordance with Rule 12.37(6) of the Rules 2016 and that no objection is raised to the Application.

IT IS ORDERED THAT

1. The Insolvency Proceedings proceeding in a County Court or County Court Hearing Centre are transferred for the sole purpose of this Application from their respective court or hearing centre to the High Court of Justice, Business and Property Courts of England and Wales at Bristol, Insolvency and Companies List (Ch) pursuant to Rule 12.37(1)(a) of the Rules and that forthwith after the making of this Order they are transferred back to the relevant County Court of County Court Hearing Centre from which they originated.
2. In respect of the compulsory voluntary liquidations listed in Part A of the Schedule, pursuant to sections 172(2) and 168(3) and (5) of the Insolvency Act 1986 (the "Act") and Rule 12.36(2)(a) of the Rules, the Outgoing Office-holder is removed as joint liquidator and the relevant Replacement Office-holder as set out in the Schedule is appointed in his place.
3. In respect of the creditors' voluntary liquidations listed in Part B of the Schedule, pursuant to section 108 of the Act and Rule 12.36(2)(a) of the Rules, the Outgoing Office-holder is removed as joint liquidator and the relevant Replacement Office-holder as set out in the Schedule is appointed in his place.
4. In respect of the members' voluntary liquidations listed in Part C of the Schedule, pursuant to sections 108 of the Act and Rule 12.36(2)(a) of the Rules, the Outgoing

Office-holder is removed as joint liquidator and the relevant Replacement Office-holder as set out in the Schedule is appointed in his place.

5. In respect of the administration appointments listed in Part D of the Schedule, pursuant to paragraphs 88 and 95 of Schedule B1 to the Act and Rule 12.36(2)(b) of the Rules Insolvency Act 1986, the Outgoing Office-holder is removed as joint administrator and the relevant Replacement Office-holder as set out in the Schedule is appointed in his place. Where any administration proposals in respect of those companies listed in Part D nominating the Outgoing Office-holder as one of the proposed joint liquidators in the event of conversion of the administration to a creditors' voluntary liquidation under paragraph 83 of Schedule B1 to the Act, the Outgoing Office-holder is to be replaced as the nominated proposed joint liquidator in each case, by the relevant Replacement Office-holder.
6. In respect of the company voluntary arrangement (nominee) appointments listed in Part E of the Schedule, pursuant to sections 7(5) and Rule 12.36(2)(d) of the Rules, the Outgoing Office-holder is removed as joint supervisor and the relevant Replacement Office-holder as set out in the Schedule is appointed in his place.
7. In respect of the bankruptcy appointments listed in Part F of the Schedule, pursuant to section 298 of the Act and Rule 12.36(2)(c) of the Rules Insolvency Act 1986, the Outgoing Office-holder is removed as joint trustee in bankruptcy and the relevant Replacement Office-holder as set out in the Schedule is appointed in his place.
8. The Applicants shall as soon as practicable (and in any event within 30 days of the date of this Order) give notice of this Order and the removal of the Outgoing Office-holder and the appointment of the Replacement Office-holders to the Secretary of State and to each of the creditors in respect of each of the Insolvency Proceedings together with, as appropriate, each debtor, bankrupt or the Registrar of Companies.
9. Each creditor may apply (within 14 days of the creditor being given notice of this Order) to vary or discharge this Order but only in so far as it relates to the Insolvency Proceeding of which they are a creditor.
10. The costs of and incidental to the Application (the "Costs") shall be expenses of each of the Insolvency Proceedings.

11. Each of the Insolvency Proceedings is to bear an equal proportion of the Costs save that, in so far as any particular insolvent estate may have insufficient funds or immediately realisable assets to meet its proportionate share of the Costs, the Applicants are to agree on the apportionment of the Costs and may make such adjustment between the insolvent estates as may be necessary to enable the Costs to be paid.
