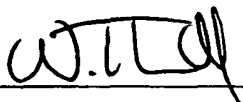

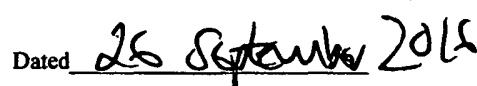

1.1 The financial statements are prepared under the historical cost convention.

2 Taxation
