AND UPON reading the letter of 18 November 2020 from the Registrar of Companies confirming no objection

AND UPON the Court being satisfied that the entries of satisfaction delivered to the Registrar of Companies pursuant to Section 859L of the Companies Act 2006 in respect of the Debenture dated 3 April 1991 between the Claimant and Barclays Bank Plc; the Guarantee and Debenture dated 15 June 1994 between the Claimant and Barclays Bank Plc; and the charge dated 24 March 2005 between the Claimant and Barclays Bank Plc over certain land and property known as 4 and 6 Anyards Road, Cobham, KT11 2JZ, hereinafter mentioned contained mis-statements which were accidental or due to inadvertence or some other sufficient cause and/or that it is just and equitable to grant relief.
