## IT IS ORDERED THAT:

- The insolvency proceedings listed in the Schedules attached hereto which are not currently before the High Court be transferred to the High Court for the purposes of this Application only, and the Applicants to ensure that a sealed copy of an Order made in the terms of this Application be lodged with the Court having jurisdiction over each case affected by such Order.
- The First Respondent, David Harry Gilbert, be removed from his office as Liquidator in respect of the company in Members' Voluntary Liquidation, which is set out in the attached Schedule A
- The Second Applicant, Malcolm Cohen, shall be appointed as Liquidator in substitution
  of the Respondent in respect of the company in Members' Voluntary Liquidation which
  is set out in the attached Schedule A
- 4. The First Respondent, David Harry Gilbert, be removed from his office as Liquidator in respect of the companies in Creditors' Voluntary Liquidation which are set out in the attached Schedule B
- The Third Applicant, Martha Hanora Catherine Thompson, shall be appointed as Liquidator in substitution of the Respondent in respect of the companies in Creditors' Voluntary Liquidation which are set out in the attached Schedule B in which she is identified as proposed nominee.
- The Fourth Applicant, Danny Nicolaas William Dartnaill, shall be appointed as Liquidator in substitution of the Respondent in respect of the companies in Creditors' Voluntary Liquidation which are set out in the attached Schedule B in which he is identified as proposed nominee
- 7 The Fifth Applicant, Sarah Megan Rayment, shall be appointed as Liquidator in substitution of the Respondent in respect of the companies in Creditors' Voluntary Liquidation which are set out in the attached Schedule 8 in which she is identified as proposed nominee.
- 8 The Sixth Applicant, James Douglas Ernle Money, shall be appointed as Liquidator in substitution of the Respondent in respect of the company in Creditors' Voluntary Liquidation which is set out in the attached Schedule B in which he is identified as proposed nominee
- 9 That the First Respondent, David Harry Gilbert, be removed from his office as Liquidator in respect of the companies in Compulsory Liquidation, which are set out in the attached Schedule C
- 10. The Fourth Applicant, Danny Nicolaas William Dartnaill, shall be appointed as Liquidator in substitution of the Respondent in respect of the companies in Compulsory Liquidation which are set out in the attached Schedule C

- 11. The First Respondent, David Harry Gilbert, be removed from his office as Administrator in respect of the companies in Administration which are set out in the attached Schedule D.
- 12. The Third Applicant, Martha Hanora Catherine Thompson, shall be appointed as Administrator in substitution of the First Respondent in respect of the company in Administration which is set out in the attached Schedule D in which she is identified as proposed nominee.
- 13 The Fifth Applicant, Sarah Megan Rayment, shall be appointed as Administrator in substitution of the First Respondent in respect of the company in Administration which is set out in the attached Schedule D in which she is identified as proposed nominee.
- 14. The Sixth Applicant, James Douglas Ernle Money, shall be appointed as Administrator in substitution of the First Respondent in respect of the company in Administration which is set out in the attached Schedule D in which he is identified as proposed nominee.
- 15 The Seventh Applicant, Kerry Franchina Bailey, shall be appointed as Administrator in substitution of the First Respondent in respect of the company in Administration which is set out in the attached Schedule D in which she is identified as proposed nominee
- 16. The Eighth Applicant, James Joseph Bannon, shall be appointed as Administrator in substitution of the First Respondent in respect of the company in Administration which is set out in the attached Schedule D in which he is identified as proposed nominee.
- 17. The First Respondent, David Harry Gilbert, be removed from his office as Nominee in respect of the companies in Company Voluntary Arrangements which are set out in the attached Schedule E.
- 18. The Third Applicant, Martha Hanora Catherine Thompson, shall be appointed as Nominee in substitution of the First Respondent in respect of the company which is set out in the attached Schedule E in which she is identified as proposed nominee
- The Fourth Applicant, Danny Nicolaas William Dartnaill, shall be appointed as Nominee in substitution of the First Respondent in respect of the company which is set out in the attached Schedule E in which he is identified as proposed nominee
- The Sixth Applicant, James Douglas Ernle Money, shall be appointed as Nominee in substitution of the First Respondent in respect of the company which is set out in the attached Schedule E in which he is identified as proposed nominee
- 21 The Applicants shall procure that, at the first convenient opportunity to do so, and in any event within 3 months of the date of an Order being made in the terms of this Application, a block advertisement in respect of each of the insolvency appointments listed in Schedules A, B, C, D and E shall be placed in the London Gazette containing notification of the following matters
  - 21.1 the removal of the First Respondent and the substitution of the Respondent by the Second, Third, Fourth, Fifth, Sixth, Seventh or Eighth Applicant, as the case may be;

- 21 2 that creditors, members (in the case of Members' Voluntary Liquidations) and debtors (where they have a financial interest in the outcome of the insolvency proceedings) have liberty to apply, within 28 days after the notice has been advertised, to vary or discharge the Order made;
- 21 3 that creditors, members (in the case of Members' Voluntary Liquidations) and debtors (where they have a financial interest in the outcome of the insolvency proceedings) have the right to object and make representations to the Respondent in respect of his release within 28 days after the notice has been advertised, and
- 21.4 in the case of the Liquidations listed in Schedules A, B and C, the Respondent will be entitled to apply to the Secretary of State for his release upon the expiry of 42 days from the date the notice has been advertised.
- 22. In relation to the insolvency proceedings listed in the attached Schedules, and insofar as the Insolvency Act 1986 or the Insolvency Rules 1986 contain any requirement for advertisement of the removal of the Respondent or his substitution by the Applicants, the requirement shall be dispensed with save to the extent provided for herein. Insofar as the Respondent is required by law to give any notice of the removal from office, the Applicants (and each of them) are entitled to sign and send any such notice on his behalf
- The period to be covered by progress reports to members and/or creditors and the dates by which those reports need to be sent to members and/or creditors and filed with the Registrar of Companies (if applicable) shall not be altered by virtue of the making of this Order or the replacement of the Respondent by the First or Second Applicant, as the case may be, pursuant to this Order; and this provision shall override any requirement in the Insolvency Rules 1986 that would otherwise require a report to be made to members and/or creditors or would otherwise alter the period to be covered by progress reports or the dates by which those reports need to be sent to members and/or creditors and the Registrar of Companies, on the termination, commencement of replacement of an office-holder's appointment, including those set out in rules 2.47(3A), 4.49B(5) and 4.49C-CVL(3) of the Insolvency Rules 1986
- In the case of the Administrations listed in the attached Schedule **E**, the First Respondent be released from all liability both in respect of any of his acts and omissions in relation to his conduct as office holder of the estate with effect from 28 days from the date when the relevant notice referred to in paragraph 21 above has been placed in the London Gazette, save in respect of any claim notified to the Respondent pursuant to the Insolvency Act 1986 and/pursuant to such other provision as may apply by that date
- In respect of those companies in administration listed in Schedule 2 and solely for the purposes of rule 7 10C(5) Insolvency Rules 1986, that the Respondents be treated as being joined as Applicants for the purpose of seeking the replacement of the First Respondent.
- In each Liquidation listed in the attached Schedules A, B(and D, the First Respondent shall not be at liberty to apply to the Secretary of State for his release until the expiry
