

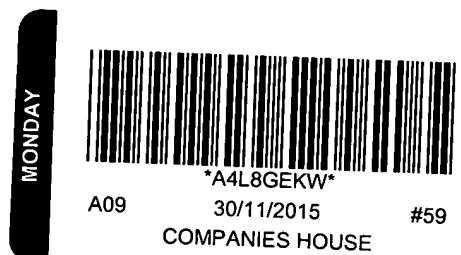



Basis of Preparation
