
**Statement of Directors' Responsibilities**

### **REPORT OF THE INDEPENDENT AUDITORS TO THE MEMBERS OF DTSD LIMITED**



**Basis of Preparation**

The financial statements have been prepared under the historical cost convention and comply with applicable accounting standards.

In order that the financial statements be prepared on a going concern basis, the Company's immediate parent undertaking has indicated that it will not call for a repayment of amounts due to group undertakings without first ensuring that the Company has adequate funds to meet its financial obligations as they fall due.
