1 ACCOUNTING POLICIES

ACCOUNTING CONVENTION

These financial statements have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") as applied to smaller entities by the adoption of Section 1A of FRS 102 and the requirements of the Companies Act 2006, including provisions of the Small Companies (Accounts and Reports) Regulations 2008, and under the historical cost convention.

FIRST TIME ADOPTION OF FRS102

These financial statements are the first financial statements the Company has prepared in accordance with Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' (FRS 102) as applied to smaller entities by the adoption of Section 1A of FRS 102 and the requirements of the Companies Act 2006. The financial statements of the Company for the period ended 29 July 2016 were prepared in accordance with the Financial Reporting Standard for Smaller Entities (FRSSE).

In accordance with section 35 of FRS 102, the Company has elected to retain its existing accounting policies for reported assets, liabilities and equity at the date of transition to FRS 102 (1 August 2015), until such time as it is not dormant.

Accordingly there are no transitional adjustments arising for the company on transition to FRS 102 that impact the Company's previously reported financial performance or position.

INCOME STATEMENT

The Company has not traded during the year or the preceding financial period. During this time the Company received no income and incurred no expenditure and therefore no Income Statement is presented in these financial statements.
