

CHAIRMAN'S REPORT ON THE RESULTS OF THE MEETINGS OF CREDITORS AND MEMBERS HELD PURSUANT TO SECTION 3 OF THE INSOLVENCY ACT 1986

The Meeting of Creditors of London Flight Centre [Stansted] Limited to consider the Administrator's Proposals for a Company Voluntary Arrangement ["CVA"] was held on 28 March 2002.

I report on the outcome of the Meeting and the subsequent Meeting of Members as required by Section 4[6] of the Insolvency Act 1986 and Rule 1.24 of the Insolvency Rules 1986.

The Proposals were APPROVED without Modification.

The Meeting was attended by representatives of ACHN Aviation Limited, Osprey Aviation Limited and, in person, by Capt Nigel Harris. Further creditors, as specified below, voted on the CVA by proxy. Capt Harris, as sole shareholder, attended the Members Meeting.

Osprey Aviation Limited was in attendance by its legal representatives, Mrs Yewings of DLA and Mr Maude of the parent company, BBA. Osprey's proxy required its representatives to vote against the CVA. However, whilst Osprey's representatives handed in a Statement of Claim amounting to £137,545.98, they had marked this claim as being subject to a claimed lien over the Love Air aircraft. When asked to "value their security", they consulted and requested a brief adjournment of the meeting. On their return, they advised the meeting that they were unprepared to put a value on their claimed security and thereupon withdrew their claim from voting. They agreed, however, that Osprey Aviation Limited was bound by the result of the meeting.
