- (1) MARLOW FOODS LIMITED registered in England and Wales with company number 01752242 (the "Chargor"), and
- (2) HSBC CORPORATE TRUSTEE COMPANY (UK) LIMITED of 8 Canada Square, London, E14 5HQ as security agent (the "Security Agent")

#### **BACKGROUND:**

- (c) all rights, powers, benefits, claims, contracts, warranties, remedies, security, guarantees, indemnities or covenants for title in respect of that asset, and
- (d) any monies and proceeds paid or payable in respect of that asset.

#### 2. FIXED SECURITY

The Chargor charges with full title guarantee in favour of the Security Agent with the payment and discharge of the Amended Secured Obligations, by way of first legal mortgage the Mortgaged Property

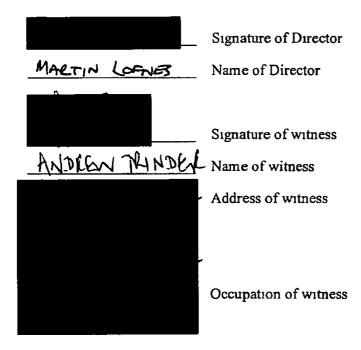
