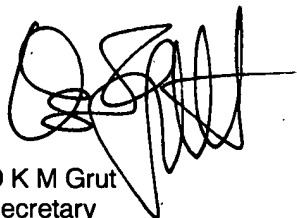
The company has not traded during the year nor the prior year and is dormant. The directors do not propose an interim or final dividend (2014: £nil).
