

The assistance will take the form of the execution by the Company, and the Company complying with and fulfilling its obligations thereunder, of the Loan Agreement, the Debenture and the Intercreditor Deed (each as defined in Appendix C to this Statutory Declaration).

#### Appendix C

The principal terms on which the assistance will be given are the Company entering into the following documents:

- (i) the Debenture and therefore:
  - (a) guaranteeing that it will pay to the Security Trustee on demand for the account of the relevant Beneficiaries all moneys and discharge all obligations and liabilities whether actual or contingent now or hereafter due, owing or incurred to the Beneficiaries (or any of them) by any other Chargor under or pursuant to the Transaction Documents;
