#### Notes to the Financial Statements for the Year Ended 31 December 2014

#### 1 Accounting policies

#### **Basis of preparation**

The financial statements have been prepared on the historical cost basis and have been prepared in accordance with applicable United Kingdom accounting standards.

The company is exempt from preparing a cash flow statement as 90% or more of the voting rights are held within the group.

#### **Exemption from preparing group accounts**

The company has taken exemption from preparing group accounts, in accordance with Section 401 of the Companies Act 2006, as it is included in consolidated accounts for a larger group which are drawn up as full consolidated audited accounts which are filed at Companies House. The results of the company and its subsidiairies are included in the financial statements of the parent undertaking which is publically available.

#### Going concern

The directors have received a letter of ongoing financial support from the ultimate parent company. The directors, having assessed the responses of the directors of the company's ultimate parent, Abbott Laboratories, to their enquiries have no reason to believe that a material uncertainty exists that may cast significant doubt about the ability of Abbott Laboratories to honour the letter of ongoing letter of financial support.

After making enquiries, the directors have a reasonable expectation that the company has adequate resources to continue in operational existence for the foreseeable future. Thus, they continue to adopt the going concern basis of accounting in preparing the annual report and financial statements.

#### Taxation

UK corporation tax is provided at amounts expected to be paid, or recovered, using tax rates and laws enacted or substantially enacted by the balance sheet date.

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date. Timing differences are differences between the company's taxable profits and its results as stated in the accounts that arise from the inclusion of gains and losses in tax assessments in periods different from those in which they are recognised in the accounts. A net deferred tax asset is recognised as recoverable only when, on the basis of available evidence, it can be regarded as more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted.

#### 2 Auditor's remuneration

Audit fees for the period of £2,000 (2013: £5,000) will be paid by other affiliates within the Abbott Laboratories group of companies.

#### 3 Staff Costs

During the current and prior year, all the directors were paid by other affiliates with the Abbott Laboratories group of companies. The directors' services to the company do not occupy a significant amount of their time. As such these directors do not consider that they receive any remuneration for their incidental services to the company for the year ended 31 December 2014. The company has no other employees.
