  Company is thereupon to be deemed to have continued in
  existence as if its name had not been struck off

- (4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (5) the Claimant does pay to the Registrar of Companies his costs of the said Application in the agreed sum of £300-00
- (6) in the event that the Claimant fail to comply with undertaking (C) above the Registrar of Companies be at liberty to commence strike off action in respect of the Company without further notice to the Claimant
