1. Accounting policies

Basis of preparation

The principal accounting policies are summarised below. They have all been applied consistently throughout the year and the preceding year.

The financial statements have been prepared

- under the historical cost convention, and
- in accordance with applicable law and accounting standards in the United Kingdom

After making enquiries, the Directors have a reasonable expectation that the Company has adequate resources to continue in operational existence for the foreseeable future. The expectation is based on the following reasons

- the Company has net current assets of £4 2 million (2011 £4 3 million), and
- the Directors believe the Willis Group is a going concern

For these reasons, the Directors have adopted the going concern basis in preparing the accounts

Parent undertaking and controlling party

The Company's

- immediate parent company and controlling undertaking is Willis Faber Limited, and
- ultimate parent company is Willis Group Holdings plc, a company incorporated in Ireland

The largest and smallest group in which the results of the Company are consolidated is Willis Group Holdings plc, whose financial statements are available to members of the public from the Company Secretary, 51 Lime Street, London EC3M 7DQ

Errors and omission provisions

Provisions comprise estimates for liabilities which may arise from actual and potential claims for errors and omissions

Cash flow statement

Under FRS1 'Cash flow statements' the Company is exempt from the requirement to prepare a cash flow statement on the grounds that the Company is a 90 per cent or more owned subsidiary undertaking and the consolidated cash flow statement that is prepared at Group level is publicly available

Errors and omissions provision

In common with many companies involved in selling personal pension plans, the Company is required by the Financial Conduct Authority to review certain categories of pension plans sold to individuals between 1988 and 1994 and to compensate those individuals who have suffered loss as a result of advice given

The cost of review (including both administration and compensation) will be met by another Group company and therefore there is no impact on the Company's profit and loss account. However, in accordance with FRS 12 "Provisions, Contingent Liabilities and Contingent Assets" the estimated liability for the review and the corresponding amount recoverable from another Group company have been shown as separate assets and liabilities.
