- 3. THAT the directors be unconditionally authorised to capitalise any undivided profits of the company arising from the sale of the "B" shares of Phillips & Drew Holding Limited.
- 4. THAT the directors be unconditionally authorised to appropriate the sum resolved to be capitalised pursuant to paragraph 3 of this resolution to the members who would have been entitled to it if it were distributed by way of dividend and in the same proportions and apply such sum on their behalf in paying up in full unissued shares of the Company of a nominal amount equal to that sum, and allot the shares credited as fully paid to those members, or as they may direct, in those proportions.
