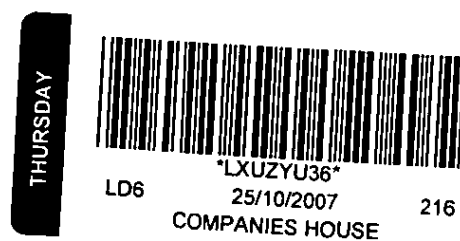

The company did not trade in the year and has been dormant, as defined in section 249AA of the Companies Act 1985, throughout the year.


DIRECTORS


