

Instrument description

"Purchase Agreement Assignment" means the agreement so entitled dated 30th July, 2001 among Airbus, BA and the Chargor relating to the Aircraft,

"Reinstatement Date" means, with respect to a notice served by one party to the Purchase Agreement Assignment on the other parties thereto in accordance with Clause 5 1(A), (B) or (C) thereof, the date of service of such notice, and

"Restated Purchase Agreement" means an amended and restated Airbus A320 family purchase agreement dated 4th October, 1999 between Airbus and BA, including the exhibits thereto and the letter Agreements

The "Assigned Property" being all present and future right, title and interest of the Chargor in and to all amounts refunded to the Chargor by Airbus pursuant to Clause 5 2(a) (iii) of the Purchase Agreement Assignment

By Clause 4 of the Security Assignment, the Chargor covenants that it will not, at any time prior to Delivery, save with the prior written consent of BA

- (A) sell, assign or otherwise dispose of the Assigned Property or create any Encumbrance upon or suffer to exist any Encumbrance upon or with respect to any of the Assigned Property except for as constituted by the Security Assignment or otherwise in favour of BA, and
- (B) amend or give any consent, waiver or approval or take any other action in connection with the Assigned Property which in each case would adversely affect the value of the title, interest or rights assigned pursuant to the Security Assignment or which would adversely affect the title, interest or rights of BA

For the purposes of this Form MR04, the following further definitions shall apply

"Delivery" means the time at which the Chargor shall have taken deliver of, and title to, the Aircraft in accordance with Clause 9 of the Novated Purchase Agreement,

"Encumbrance" means any mortgage, charge (whether fixed or floating), pledge, lien, hypothecation, assignment, trust arrangement or security interest of any kind securing any obligation of any person or any title transfer and/or retention arrangements having a similar effect,
