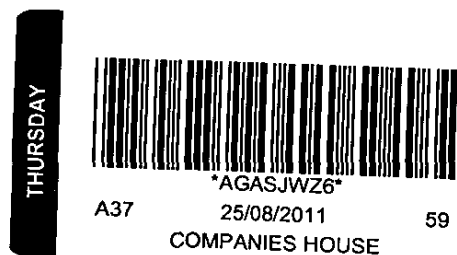




Directors' responsibilities
