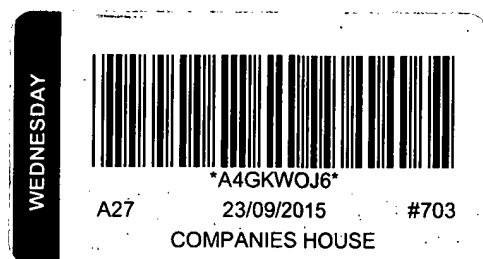




Directors' responsibilities:
