During the financial year, the Company has not traded and there has been no income or expenditure. No change in the Company's position has, therefore, arisen.

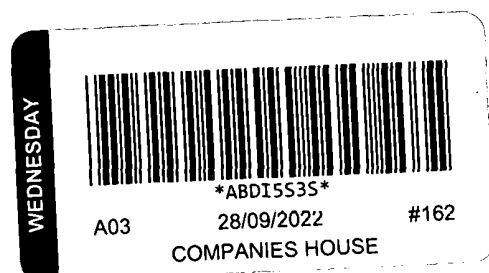
