1. ACCOUNTING POLICIES

Basis of accounting

The financial statements have been prepared under the historical cost convention.

The company has taken advantage of the exemptions in Financial Reporting Standard No. 1 from the requirement to produce a cash flow statement on the grounds that it is a small company.

Cash flow statement

The directors have taken advantage of the exemption in Financial Reporting Standard No 1 (revised) from including a cash flow statement in the financial statements on the grounds that the company is small.

Turnover

Turnover comprises the value of sales excluding value added tax and trade discounts.

Foreign currencies

Assets and liabilities in foreign currencies are translated into sterling at the rates of exchange ruling at the balance sheet date. Transactions in foreign currencies are translated into sterling at the rate of exchange ruling at the date of the transaction. Exchange differences are taken into account in arriving at the operating profit.

5. RELATED PARTY TRANSACTIONS

The company's ultimate holding company is Technology in Action Group Limited, a company incorporated in the United Kingdom and registered in England and Wales.

During the year the company was charged £12,000 (2001: £12,000) in management fees by Technology in Action Group Limited. At the balance sheet date the amount due to Technology in Actio Group Ltd was £2000.

During the year the company purchased goods in the normal course of business from Distributed Intelligence Systems SARL for £32 (2001 - £nil). The price charged was the cost price plus 15% in the case of each individual purchase. At the balance sheet date the amount due to Distributed Intelligence Systems SARL was £32 (2001: £nil).

During the year the company paid royalties of £5,904 (2001: £5,904) to Retail Research and Development Limited. At the balance sheet date the amount due to Retail Research and Development Ltd was £984 (2001: £119).

During the year the company made no purchases from Distributed Intelligence Systems Ltd in the normal course of business. The amount due from Distributed Intelligence Systems Ltd at the balance sheet date was £4,000 (2001: £nil).

During the year the company made no purchases from Retail Computer Services Ltd. The amount due to Retail Computer Services at the balance sheet date was £7 (2001: nil).

These companies are all fellow subsidiaries of Technology In Action Group Limited.
