SECURITY ACCESSION DEED
APRIL 2015

THIS SECURITY ACCESSION DEED is made on 2 APRIL 2015

BETWEEN:

- (1) THE COMPANIES LISTED IN SCHEDULE 1 (the "New Charging Companies" and each a "New Charging Company");
- (2) TIG FINCO PLC, a company incorporated in England and Wales with registered number 9424525 (the "Company"), for itself and as agent for and on behalf of each of the existing Charging Companies; and
- (3) THE BANK OF NEW YORK MELLON, LONDON BRANCH as security trustee for itself and the other Secured Parties (the "Security Agent").

RECITAL:

This deed is supplemental to a debenture dated 2 APRIL 2015 between, *inter alia*, the Company, the Charging Companies named therein and the Security Agent (the "Debenture").

NOW THIS DEED WITNESSES as follows:

1. INTERPRETATION:

1.1 Definitions

Terms defined in the Debenture have the same meaning when used in this deed.

In this deed:

"Trust Accounts" means any account (including any re-designation, replacement, sub-account and/or any related deposit account of any such account or accounts) of any Group Company which is required by the FCA and/or the PCA to be established for the purposes of ring-fencing amounts required to achieve an orderly wind-down of all of the Group's regulated businesses including the payment of all costs, expenses and liabilities relating thereto; as referred to in Clause 3.9(a) (*Trust Accounts*) of the Debenture and as set out in part 2 of Schedule 3 of this deed.

1.2 Construction

Clause 1.2 (*Construction*) and Clause 1.3 (*Other References*) of the Debenture will be deemed to be set out in full in this deed, but as if references in those clauses to the Debenture were references to this deed.

2. ACCESSION OF NEW CHARGING COMPANY

2.1 Accession

Each New Charging Company agrees to be a Charging Company for the purposes of the Debenture with immediate effect and agrees to be bound by all of the terms of the Debenture as if it had originally been a party to it as a Charging Company.

2.2 Covenant to pay

Each New Charging Company as primary obligor covenants with the Security Agent (for the benefit of itself and the other Secured Parties) that it will pay and discharge on demand the Secured Obligations when it falls due for payment.

2.3 Fixed Charges

Subject to Clause 2.3(c) below, each New Charging Company, as continuing security for the payment of the Secured Obligations, charges in favour of the Security Agent with full title guarantee the following assets, both present and future, from time to time owned by it or in which it has an interest:

- (a) by way of first legal mortgage, the Premises (including the property specified in Schedule 2) together with all buildings and fixtures (including trade fixtures) on that property; and
- (b) by way of first fixed charge:
 - (i) all other interests (not charged under Clause 2.3(a)) in any freehold property or Leasehold Property, the buildings and fixtures (including trade fixtures) on that property, all proceeds of sale derived therefrom and the benefit of all warranties and covenants given in respect thereof and all licences to enter upon or use land and the benefit of all other agreements relating to land;
 - (ii) all the Subsidiary Shares and Investments (including the shares specified in Schedule 3) and all corresponding Distribution Rights;
 - (iii) all plant, machinery, vehicles, computers, office and other equipment and the benefit of all contracts, licences and warranties relating thereto;
 - (iv) all Book Debts and all rights and claims against third parties and against any security in respect of those Book Debts;
 - (v) all debts and monetary claims (other than Book Debts) and all rights against third parties in respect of such debts and monetary claims;
 - (vi) subject to Clause 3.9 (*Trust Accounts*) of the Debenture, all monies standing to the credit of any and all its accounts (including the Collection Accounts specified in Schedule 4 and the Nominated Accounts) with any bank, financial institution, or other person and all rights related to those accounts;
 - (vii) all its Intellectual Property (including the Intellectual Property specified in Schedule 5);
 - (viii) all rights, title and interest in and to the Hedging Agreements;
 - (ix) the benefit of all consents and agreements held by it in connection with the use of any of its assets;
 - (x) its goodwill and uncalled capital; and
 - (xi) if not effectively assigned by Clause 2.5 (*Security Assignment*), all its rights and interests in (and claims under) the Assigned Agreements.

- (c) The parties acknowledge that the ranking of the Security created pursuant to Clauses 2.3(a) and (b) (*Fixed Charges*) is subject to the Intercreditor Agreement and that the application of proceeds pursuant to this deed is provided for in the Intercreditor Agreement.

2.4 Floating Charge

- (a) As further continuing security for the payment of the Secured Obligations, subject to Clause 2.4(b) below, each New Charging Company charges with full title guarantee in favour of the Security Agent (for the benefit of itself and the other Secured Parties) by way of first floating charge all its assets, both present and future, not effectively charged by way of first fixed charge under Clause 2.3 (*Fixed Charges*) or assigned under Clause 2.5 (*Security Assignment*).
- (b) The parties acknowledge that the ranking of the security created pursuant to Clause 2.4(a) (*Floating Charge*) is subject to the Intercreditor Agreement and that the application of proceeds pursuant to this deed is provided for in the Intercreditor Agreement.

2.5 Security Assignment

As further continuing security for the payment of the Secured Obligations, each New Charging Company assigns absolutely with full title guarantee to the Security Agent (for the benefit of itself and the other Secured Parties) all its rights, title and interest in and to the Assigned Agreements (including any identified in Schedule 6 *identified in Schedule 6*), provided that on payment or discharge in full of the Secured Obligations the Security Agent will at the request and cost of the relevant New Charging Company re-assign the relevant rights, title and interest in the Assigned Agreements to the relevant New Charging Company (or as it shall direct).

3. CONSTRUCTION OF DEBENTURE

The Debenture and this deed shall be read together as one instrument on the basis that references in the Debenture to "this deed" will be deemed to include this deed.

4. CONSENT OF EXISTING CHARGING COMPANIES

The existing Charging Companies agree to the terms of this deed and agree that its execution will in no way prejudice or affect the security granted by each of them under (and covenants given by each of them in) the Debenture.

5. NOTICES
