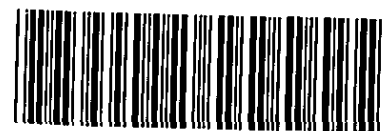



**Notes**

1.
