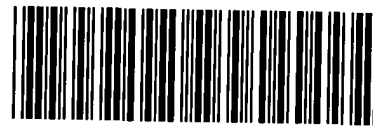

**Statements by the Directors required under the Companies Act 2006**

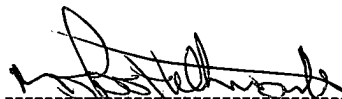
For the year ended 31<sup>st</sup> March, 2018 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies.
