#### Statement of Director's responsibilities





### Notes on the Accounts for the year ended 31st March, 2010

#### 1 Accounting Policies

- a) The accounts have been prepared under the Historical Cost Convention. Therefore the abbreviated restatement of the Profit and Loss Account prescribed in Financial Reporting Standard 3 is not required.

#### b) Cash Flow Statement

The Company has taken advantage of the exemption for the small companies (as defined by S 246 to 249 Companies Act 1985) granted in Financial Reporting Standard 1.

#### 2 Activities

The only activity is the management of flats at 10 Trafalgar Road, Bath, and all income comes from re-charges to the Lessees.

#### 3 Employees

There were no employees.

#### 4 Corporation Tax

Other than tax deducted at source on the interest received, there is no Corporation Tax payable on these accounts.
