#### Statement of Director's responsibilities




For the year ending 31<sup>st</sup> March, 2014, the company was entitled to exemption from audit under section 477 of the Companies Act 2006.

The only activity is the management of flats at 18 Grosvenor Place, Bath, and all income comes from re-charges to the Lessees.
