at any time prior to the effective date of the scheme sanctioned by the Court in its order dated 30 October 2017 pursuant to claim CR-2016-006704 (the **Effective Date**).

IT IS ORDERED that the cancellation of 135,283,332 of the Company's ordinary shares of £1 each and the cancellation of the whole of the amount standing to the credit of the Company's share premium account, resolved and effected by special resolutions duly passed by a written resolution of the sole shareholder of the Company dated 11 July 2017 be and the same is hereby confirmed in accordance with the provisions of the above-mentioned Act.

AND the Statement of Capital set out in the Schedule is approved.

AND IT IS ORDERED:

- 1. that after the Effective Date this Order be produced to the Registrar of Companies and that an office copy be delivered to him together with a copy of the Statement of Capital; and
- 2. that notice of the registration by the Registrar of Companies of this Order and of the Statement of Capital be published once in The Times newspaper within 21 days after such registration.
